Firm History

Prospector Partners began in 1997 when John Gillespie reunited with his mentor, Jack Byrne, who became a founding investor of Prospector. Byrne was the legendary CEO of GEICO (acquired by Berkshire Hathaway), Fireman's Fund (acquired by AIG), and White Mountains Insurance Group. Warren Buffett referred to Jack Byrne as "the Babe Ruth of insurance."





Batting average is a statistical measure used to measure a manager's ability to meet or beat an index. Active Share is a measure of the percentage of stock holdings in a manager's portfolio that differs from the benchmark index. Price/sales ratio is a valuation ratio that compares a company's stock price to its revenues. Sharpe Ratio is a risk-adjusted measure calculated by using standard deviation and excess return to determine reward per unit of risk. Standard Deviation is a statistical measurement of dispersion about an average, which depicts how widely returns varied over a certain period of time. Up Capture Ratio is the statistical measure of an investment manager's overall performance in up-markets.
